LETTER OF AGREEMENT – CORPORATE EXECUTIVE HEALTH

This Letter of Agreement is entered between the Presidential Healthcare Center and _____ and this letter of agreement shall supersede all other written and/or verbal agreements, amendments, exhibits and/or promises.

The Presidential Healthcare Center Obligations:

The Presidential Healthcare Center agrees to provide *Preventive Executive Physicals* for _____ executives who are authorized an executive physical benefit. *Preventive Executive Physicals* will be custom-tailored to executive personal medical history, taking into account recent medical results, existing medical conditions, family history, and other medical risks. Each *Preventive Executive Physical* will be comprehensive including laboratory tests, imaging studies, and procedures consistent with the available tests listed on the Presidential Healthcare website, www.PresidentialHealthcareCenter.com. Additionally, the Presidential Healthcare Center will provide complimentary follow-up and coordination of care for those executives actively employed by _____ and enrolled in the Presidential Executive Health annual executive health program. Furthermore, family members of _____ executives will be offered *Preventive Executive Physicals* under the same favorable terms as _____ executives.

Corporate Obligations:

_____ agrees to make its eligible executives aware of the opportunity for participation in the Presidential Healthcare Center executive health program. To facilitate such awareness, _____ and the Presidential Healthcare Center will provide a letter of eligibility notification, with mutually agreed to content, to each eligible executive. Additionally, the Presidential Healthcare Center will be included in any new executive health benefit publications which are routinely distributed to eligible executives. Additionally, to facilitate medical care and follow-up, the Presidential Healthcare Center will be provided the Presidential Healthcare Center the names, company titles, address, and phone numbers of eligible executives. _____ will also provide timely notification to the Presidential Healthcare Center regarding any executive departures from the company, any additions to the executive staff, or any changes in *Preventive Executive Physical* benefit eligibility.

It is mutually agreed by both _____ and the Presidential Healthcare Center that specific test results, diagnoses, and other personal medical information will only be released to the individual executive or family member patients in accordance with this agreement and the Health Insurance Portability and Accountability Act of 1996 (HIPAA).

The annual cost for each *Preventive Executive Physical* will be \$_____. However, it will be necessary for insurance to provide coverage for diagnostic laboratory testing, imaging, or outside consultations that may be performed to evaluate symptomatic medical problems not part of the *Preventive Executive Physical*.
